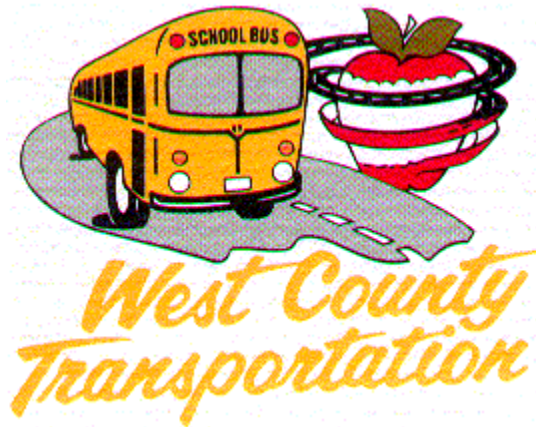

Read the question again prior to picking the correct answer.

Eliminate obvious wrong answers.

Pick the most correct answer.

Then read the question again with the answer attached to the end to see if it makes sense.

Remember your first choice is usually correct.
